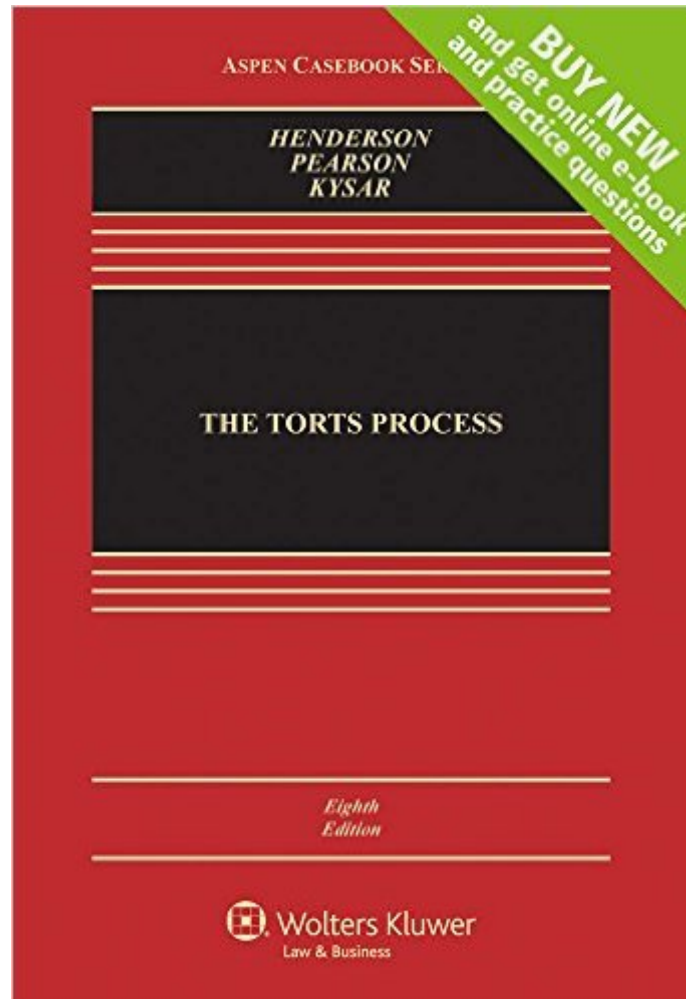

In addition, the Eighth Edition discusses the BP Oil Spill Fund in the chapter on alternative compensation mechanisms.
